7 Relating to Macon County; providing for an
8 additional **expense allowance and salary** for the Macon County
9 Commissioners, the Chair of the Macon County Commission, the
10 Macon County Revenue Commissioner, Judge of Probate, and the
11 Sheriff of Macon County.

12 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

13 Section 1. Beginning on the first day of the month
14 following the effective date of this act, each Macon County
15 Commissioner, the Chair of the Macon County Commission, the
16 Macon County Revenue Commissioner, Judge of Probate, and the
17 Sheriff of Macon County shall respectively receive an
18 **additional expense allowance** of four thousand eight hundred
19 dollars **(\$4,800)** per annum, payable in equal monthly
20 installments. The expense allowance shall be in addition to
21 all other compensation, expense allowances, or benefits
22 granted to each Macon County Commissioner, the Chair of the
23 Macon County Commission, the Macon County Revenue
24 Commissioner, Judge of Probate, and the Sheriff of Macon

1 County and, where applicable, may be treated as compensation
2 for retirement contributions.

3 Section 2. This act shall become effective on the
4 first day of the third month following its passage and
5 approval by the Governor, or its otherwise becoming law.
